Licensee represents, warrants, and agrees that the Project shall not defame, disparage or be derogatory or critical of The Center or any officer, director, agent, employee, affiliate, parent or subsidiary of The Center or of any programs from which the Licensed Materials are taken or which are produced or distributed by The Center.
